14.1 PROCEDURE WITH CHECK POINTS

1.	Ensure that-	
	 the company has received a special notice from (a) a person who wishes to get appointed or, (b) by a member proposing his/her directorship, at the general meeting, at least 14 days before the date of general meeting and the aforesaid person has deposited Rs. 1,00,000/(one lakh) along with such notice except in cases: the aforesaid person to be appointed as an independent director, or 	
	- the aforesaid person is recommended by nomination and remuneration committee or by the board, if no nomination and remuneration committee is constituted. {Section 160(1) of the Act}	
	 the person proposed to be appointed as a director in a company, other than a company registered under Section 8 (non-profit company) of the Companies Act, 2013 {Section 165(1) of the Act}: shall not hold office as a director including any alternate 	
	directorship in more than 20 companies excluding directorship in dormant companies;	
	- shall not hold office in more than 10 public companies including the private companies which are holding or subsidiary of public companies;	
	 shall not be appointed if such person was associated with the company as a small shareholder's director during a period of 3 years prior to his appointment. 	
	• the person has a valid Directors Identification Number (DIN), and if not having DIN, make arrangements for Digital Signature Certificate (DSC) and DIN of the person to be appointed as a director {Section 152(3) of the Act}.	
	• a person, who is intended to be appointed, shall not be eligible for appointment, if he/she has any disqualification for appointment under section 164 of the Act {Section 164 of the Act}.	
	• the company is incorporated before 1 st January, 2018 and the status of the company is 'ACTIVE COMPLIANT COMPANY' otherwise the Registrar shall not accept and take on record the e-Form DIR-12 which is required to be filed in case of change in director. (Fourth Proviso of Rule 25A of the Companies (Incorporation) Rules, 2014}, and if the status of the company is 'ACTIVE NON-COMPLIANT', then first complete the formalities of filing of e-FORM INC-22A as per rule 25A of the Companies (Incorporation) Rules, 2014.	
2.	Obtain consent in writing, on or before appointment, from the appointee director to act as director in Form DIR-2 and an intimation in writing, on or before appointment, by the appointee director in Form DIR-8 confirming that he/she is not disqualified to act as a director under Section 164 of the Companies Act, 2013 {Section 152(5) and Section 164 of the Act }.
